- 1) Entry Deadline: Reserve entries/payment must be received no later than April 19, 2024. Walk-ins OK if space available.
- 2) Eligibility: **All bowlers must be current members of USBC**. Bowlers must be one of the following: active SIR members, those with SIR applications pending; guest of a SIR member (man or woman); wives or widow of SIR members.
- 3) Multiple Participation:
 - a) This is a **Doubles, Singles and Team** tournament. With a different partner, a bowler may bowl and cash two times in the **Doubles and Team** event.
 - b) One bowler must be a SIR member in **Doubles**; two must be SIR members in each **Team**.
 - c) A bowler may bowl **Singles** only one time.
 - d) The first **Doubles** and **Team** score will be used for **All Events**.
- 4) Handicap: This is a handicapped tournament based on 100% of the difference between 230 and the bowler's average in Singles; 100% of 460 for Doubles; 100% of 920 for Team.
- 5) Entering Average: **Entry average requirement is listed in order of decreasing priority**.
 - a) 2022-23 USBC Standard Composite Average (21 games or more). IF NONE;
 - b) 2021-22 USBC Standard Composite Average (21 games or more). IF NONE;
 - c) Current **verifiable** USBC sanctioned league average of 21 games or more at entry time by supplying secretary signed current league sheet at check in.
 - d) If average is unverifiable, entrant must bowl scratch (average of 230 = zero handicap). Averages verified on www.bowl.com will require no further verification.
- 6) Divisions: There will be **four** Divisions. Divisions **1** and **2** will be divided by average after close of mail-in entries. Division **3** will be a Women's Division in SINGLES and ALL EVENTS. Division **4** will be SCRATCH in ALL EVENTS.
- 7) Entry Fees/Expenses:
\$23.00 per event: Singles/Doubles/Team. \$5.00 optional All Events (*Scratch and/or Handicapped*).
Lineage: \$11.00; Expenses: \$1.60, SIR State Fee \$.40; Prize Fund: \$10.00
- 8) Prize Fund: All Prize funds will be returned 100% on a ratio of at least one to every five entries per Division including optional All Events. Prize money will be mailed to Team Captain/Prize Coordinator listed on the entry form. **Branch 160 will likely add additional \$ to sweeten the prize fund.**
- 9) Sanctioned Tournament and Applicable Rules:
This Tournament shall be conducted under USBC Rules, except for changes noted on this form.
USBC Rules 319a-2 (ten pin) and 314 (refunds) are waived.
Any disputes shall be resolved by the Tournament Committee, and their decision is final.

COVID REQUIREMENTS: At present there are no SIR State, Nevada State or local requirements related to COVID 19 protection such as wearing masks and social distancing. Should mandates return before the tournament, you will be notified.
